

Luxor Network Privacy Policy

Your privacy is very important to us. Accordingly, we have developed this policy in order for you to understand how we collect, use, communicate and disclose and make use of personal information. The following outlines our privacy policy.

- (a) Before or at the time of collection personal information, we will identify the purpose for which information is being collected.
- (b) We will collect and use personal information solely with the objective of fulfilling those purposes specified by us and for other compatible purposes, unless we obtain the consent of the individual concerned or as required by law.
- (c) We will retain personal information as long as necessary for the fulfillment of those purposes.
- (d) We will collect personal information by lawful and fair means and, where appropriate, with the knowledge or consent of the individual concerned.
- (e) We will not sell the information collected to the third parties.
- (f) Personal data should be relevant to the purposes for which it is to be used, and, to the extent necessary for those purposes, should be accurate, complete, and up-to-date.
- (g) We will protect personal information by reasonable security safeguards against loss or theft, as well as unauthorized access, disclosure, copying, use or modification.
- (h) We will make readily available to customers information about our policies and practices relating to the management of personal information.

We are committed to conducting our business in accordance with these principles in order to ensure that confidentiality of personal information is protected and maintained.

INFORMATION WE COLLECT

We collect information submitted by you for use which, are typically associated with website processes. Exclude your name, email address, contact numbers, address, marital status, member code, photographs given to Luxor Network Sdn Bhd and/or taken at official company functions, race, nationality, age, sex, date of birth, MyCard number and job details. This information is collected at various places, for instance: when you submit an enquiry, subscribe to receive newsletters, participate in polls or contests, or interact with special-event or programs.

We collect information about you and when you provide it, we may also collect information about those you know. For example, your upline or information about someone whom you would like to know more about our products or someone whom you would like to refer to our company.

DISTRIBUTORS

They have agreed not to share your Information with any non-affiliated third parties, and are obligated to observe the intent of this Privacy Policy. In the ordinary course of supporting your business, information about you and your orders might be shared with your sponsoring Distributor and immediate upline Distributor. You have the opportunity to let us know, however, if you do not want any Personally Identifiable Information shared beyond your immediate upline Distributor.

ACCESSING AND CORRECTING YOUR INFORMATION
